



Competition's terms & conditions

«Brussels' Calling»

Article 1: Organization

Verbier Tourisme SA (hereinafter "Verbier Tourisme"), with registered office at Route de Verbier Station 61, 1936 Verbier, Switzerland, is organizing a competition (hereinafter the "Competition") as part of a promotional event in Brussels from September 25 to 27 entitled «Brussels's Calling».

Article 2: Conditions of Participation

The competition is free, there is no obligation to purchase.

As a prerequisite for participation in the competition, these regulations must be accepted.

Participants must provide their contact details (last name, first name and email address) completely and correctly.

Only natural persons of legal age who have their civil rights at the time of participation can take part in the competition.

Persons who are directly or indirectly involved in the development, organization or course of the competition, all employees and employees of Verbier Tourisme and its partners, as well as the family members of the above-mentioned persons are excluded from taking part in this competition.

Article 3: Conditions of the competition

Participation in the competition takes place exclusively via the online registration form. Participants undertake to fill out all fields with correct information in order to take part in the competition.

Registering for the competition obliges you to acknowledge and comply with these regulations. Registration will be confirmed as soon as all mandatory information has been correctly entered in the form displayed. Registrations that are incomplete, made after the closing date or with incorrect information are considered inadmissible. Participants who violate any of the general conditions of participation will be excluded without further notice.

The registration period begins on Monday, September 23, 2024 and ends on Sunday, September 29, 2024. Each person may only take part in the competition once during the entire duration of the competition.



Article 4: Determination of the winners of the competition

The winners will be notified and further communications regarding receipt or delivery of the prizes will be made within seven days of the draw exclusively via the contact details provided during registration.

Verbiere Tourisme reserves the right to change, interrupt or cancel this competition without prior notice.
